

PLANNED PREVENTIVE MAINTENANCE CONTRACT

1. PREVENTIVE MAINTENANCE

Is the periodic checking adjustments alignment and cleaning of the equipment necessary lubrication of mechanical parts and testing under normal working conditions

The Company shall make preventive maintenance visits at an interval of ones in a six month or as per manufacture's recommendations during each contract year at reasonably spaced intervals such visit take place during normal working hours. The next PPM due is also mentioned in the records. The first party will provide PPM sticker with service report for each equipment at the same time of PPM. Every PPM visit will be followed by a service report for the equipment with a sign off from the Facility Director or any responsible official of the Facility.

2) CALIBRATION/VERIFICATION REQUIREMENTS

Most of the Calibration is done with the periodic Prevention maintenance schedule. Calibrate medical equipments at the frequency specified by the manufacturer .The next calibration due is also mentioned in the records.

3) CORRECTIVE / BREAKDOWN REPAIR:

The Company will attend all corrective/ breakdown calls however, that doesn't come under contract. We charge you extra for service.

4) RESPONSE TIME:

ABONE agrees to provide the services referred to in Schedule 1 on the Equipment listed subject to the terms and conditions of this agreement.

5) PAYMENTS

Payment shall be made by CUSTOMER as per agreed payment terms.

If payment or the service charge is not made within such period. ABONE shall have the right to terminate this agreement with immediate effect.

6) CHARGES

(a) CUSTOMER will be invoiced by ABONE for the charge shown in Schedule 1 on an basis in advance.

(b) ABONE hereby agrees that it will not increase the charge payable hereunder within twelve months from the date hereof.

7) CUSTOMER RESPONSIBILITIES

- (c) Shall be charged separately for all labour, and materials required to place the equipment in good operating condition.
